## AUDIT RESULTS

This report describes the overall results and conclusions for the areas we examined. In those selected areas, District operations complied with applicable state laws, regulations, and its own policies, and provided adequate controls over the safeguarding of public resources.

### About the audit

This report contains the results of our independent accountability audit of the South Kitsap Water Reclamation Facility from January 1, 2016 through December 31, 2017.

Management is responsible for ensuring compliance and adequate safeguarding of public resources from fraud, loss or abuse. This includes the design, implementation and maintenance of internal controls relevant to these objectives.

This audit was conducted under the authority of RCW 43.09.260, which requires the Office of the State Auditor to examine the financial affairs of all local governments. Our audit involved performing procedures to obtain evidence about the District's uses of public resources, compliance with state laws and regulations and its own policies and procedures, and internal controls over such matters.

In keeping with general auditing practices, we do not examine every transaction, activity or area. Instead, based on our risk assessment for the years ended December 31, 2017 and 2016, the areas examined were those representing the highest risk of fraud, loss, abuse, or noncompliance. The following areas were examined during this audit period:

- Procurement for public works projects and purchases
- Evaluation of controls over disbursements

## INFORMATION ABOUT THE DISTRICT

The South Kitsap Water Reclamation Facility is a joint venture of West Sound Utility District No. 1 and the city of Port Orchard to construct and operate a wastewater treatment plant. The treatment plant started operation in May 1985.

The Facility is operated by West Sound Utility District and is governed by the same three-member Board of Commissioners. A Sewer Advisory Committee was established to plan for future Facility capital improvements, recommend an appropriate level of operation and capital funding and overview the preparation of the annual budget for the City's and District's final approval. The District operated on \$3.2 and \$3.3 million in revenues in 2016 and 2017, respectively.
